Read: Notification of NCTE, New Delhi dated.01.01.2004 published in the Gazette of India Part III – Section 4 as No.3 on 05.01.2004

The NCTE, New Delhi in its Notification dated.01.01.2004 decided to dispense with the requirement of "No Objection Certificate" from State/UT Government for those institutions already running B.Ed programmes recognised by NCTE and seeking recognition to start a course or training in Elementary Teacher Education for a period of three years from the date of notification of these regulations in the Official Gazette.

The Pavithra Rao Educational Society, Himayatnagar, Hyderabad, Andhra Pradesh is running Rashmidhar Teja College of Education, Korutla, Karimnagar District, Andhra Pradesh which has been granted recognition by SRC-NCTE has submitted an application to start Elementary (D.Ed) course by deriving the benefit of above said regulation on 03.02.2004.

The application for starting Rashmidhar Teja D.Ed College, Jagtiyal Revenue Division, 1-1-251, Bheemunidubba New Bus Stand, Korutla, Karimnagar District-505326, Andhra Pradesh was considered by SRC-NCTE under Section 15 of NCTE Act, 1993. Accordingly, inspection of the institution was carried out on 18.05.2005 and the report of inspection team and other documents furnished by the institution along with the application were considered by the Southern Regional Committee in its meeting held on 2nd July, 2005. The Regional Committee observed that the institution has made satisfactory arrangements in respect of infrastructural and instructional facilities for starting D.Ed course and decided to permit the institution to start Elementary (D.Ed) course from the session 2005-06.

Hence the order.
